

AiYellow.com Conditions of Use

- 1. We (AmarillasInternet Corporation o AiYellow.com) provide the AiYellow.com website. We are a Corporation registered in (and ruled by the laws of) Florida State, United States of America (registration number EIN 26-3779909). Our registered office is at 25 SE 2nd Ave. Suite 410 Ingraham Building, Miami, FL. 33131.
- 2. These conditions of using our websites (the "Conditions") govern the terms of use of AmarillasInternet Corporation websites.
- 3. We legally own a wide range of intellectual property rights used in and relating to the AmarillasInternet Corporation websites, including:
 - a. each of the trade marks AmarillasInternet Corporation, AmarillasInternet, AiYellow.com and related logos;
 - b. our business-listings directory database;
 - c. the design, text, graphics, articles, blogs and other content of the AiYellow web pages, together with all the web addresses associated with those web pages, other than those which we use under license;

About these conditions

- 4. For the purpose of these Conditions, the term "AiYellow.com Websites" refers collectively to the following AmarillasInternet Corporation websites and the term "AiYellow.com Website" refers to any one of the following:
 - a. Ai Yellow Pages;
 - b. Ai White Pages;
 - c. Ai Website Builder;
 - d. UbiZ;
 - e. Yellow Heart Program;
 - f. Click to Help Program;
 - g. Ai Token B2B Ai Coins;
- 5. including any other website we may own or run from time to time that links through to these Conditions.
- 6. If you log on to or use any part of the AiYellow Websites you agree to these Conditions. If you do not want to agree to these Conditions, do not log on to or use the AiYellow Websites.
- 7. We may change these Conditions at any time without giving you notice. Please check these Conditions from time to time for any changes. By continuing to use a AiYellow Website you agree to all the changes we make to these Conditions.

Use

- 8. Where any of the AiYellow Websites allow you to:
 - a. contact the organisations that provide these goods and services; or
 - b. bid for certain AiYellow products and services.
- 9. we may limit your access to all or some parts of the AiYellow Websites or may not accept you as an AiYellow business account holder (as the case may be). We may, in our absolute discretion, accept or refuse any registration application.
- 10. Please do not tell other people your log in details, password or any other piece of information that is part of our security procedures. We take steps to prevent people misusing the AiYellow Websites and to make sure that our rights are not affected. You are responsible for the content of any material provided using your log in details and password. You must notify us immediately if your log in details and/ or password, are used without your permission. We have the right to disable any account if, in our absolute discretion, you have failed to comply with these Conditions, including if your display name is inappropriate in any way.
- 11. You acknowledge and agree that:
 - a. you are responsible for any AiYellow account (Virtual Office, Smart Office) you use whilst on any of the AiYellow Websites and maintaining the confidentiality of your password and you shall take all necessary steps to ensure that your password is kept confidential and secure;



- b. you shall inform us immediately if you have any reason to believe that your password has become known to anyone else, or if the password is being used or is likely to be used in an unauthorised manner;
- c. you accept all responsibility for any and all activities that occur at or through your AiYellow Account (whether authorised or not); and you shall ensure that all information that you provide to us is and remains at all times true, correct and complete.
- 12. We process information about you in line with our <u>Privacy policy</u>. By using the AiYellow Websites, you agree to the way in which we process your personal information.
- 13. You must make sure that:
 - a. all information you give us is true, correct and complete and let us know if it changes; and (where applicable).
 - b. all electronic files you give us use properly licensed software and are free from viruses and other malware.

Our Responsibilities

- 14. Subject to these conditions, we shall endeavor to make the AiYellow Websites available.
- 15. You cannot use a AiYellow Website:
 - a. for any unlawful purpose;
 - b. to harm, threaten, abuse or harass another person, or in a way that invades someone's privacy or is (in our reasonable opinion) offensive or is unacceptable or damaging to us or any other company within our group of companies;
 - c. to create, check, confirm, update or amend your own or someone else's databases, records, directories, customer lists, mailing or prospecting lists;
 - d. to provide any kind of commercial information service;

- 18. We may suspend and have the right to modify all or any part of the AiYellow Websites, (including any services or products that we offer on the AiYellow Websites) or your access to them, at any time without telling you beforehand. We won't be responsible to you for any changes we make or for ceasing operation of all or any part of the AiYellow Websites. In doing so we will endeavor not to diminish the value of any products or services that we offer to any material degree.
- 19. We may suspend or cancel your use of the AiYellow Websites or your online account with AiYellow or user details relating to any of the AiYellow Websites if:

- e. Bankruptcy or insolvency proceedings are brought against you, or a receiver, an administrative receiver or an administrator is appointed over any of your assets or, if you are a company, you go into voluntary liquidation (except for the purposes of amalgamation or reconstruction).
- 20. To be clear, if we suspend or cancel any of your AiYellow Accounts or AiYellow user details, you will still have to pay us for any products or services you have bought from us.

Material provided to any AiYellow Website

- 21. If you provide any material to any AiYellow Website (for example, by commenting on a blog, posting a review or uploading any other content including a video), you agree to grant us permission, irrevocably and free of charge, to use your material in any way we want on any website or otherwise (including altering and adapting it for operational or editorial reasons) in any media worldwide, which may include syndicating the material to selected third party social media and networking sites.
- 22. After posting or emailing your material to any AiYellow Website, you continue to own that material, and you continue to have the right to use your material in any way you choose.
- 23. Please choose carefully any information you post on any AiYellow Website, as it will be available for public viewing. By providing any material to a AiYellow Website, and for us to be able to use it, you confirm you and the material comply with all obligations set out in these conditions, and in particular that:
 - a. your material is your own original work, or you are authorized to provide it any AiYellow Website;
 - b. your material is not defamatory (that is, it does not damage someone's good reputation), does not contain any material which is harassing, threatening, obscene, offensive, hateful, abusive or inflammatory;
 - c. your material does not take away or affect any other person's privacy rights, contract rights or any other rights;

 - c. restrict, suspend or stop your access to all or any part of any AiYellow Website, at any time.
- 26. We will usually display your name with your material on any AiYellow Website, unless you ask us not to (as long as it is possible to do this). We may need to contact you for administrative purposes or to make checks on your material. For full details of when and how we may contact you, please see our Privacy policy.
- 27. If you do not want to grant us the permission set out above on these terms, please do not provide any material to any AiYellow Website.

- 39. A person who is not a party to these Conditions shall have no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any of the provisions of these Conditions.

The Whole Agreement
